Coutts Conspiracy to Commit Murder Investigation

On January 29th, 2022, semi-truck drivers blocked the Coutts, Alberta – Sweet Grass, Montana, international border, preventing traffic from crossing and disrupting a major artery for the Alberta economy. The RCMP deployed a large contingent of police to deal with the blockade. An undercover operation was undertaken to infiltrate the leadership group. The investigation led to discovery of a plot by the group to prepare for a war against police. The escalation in the threat to both the police and public led to the arrest of 13 people on February 14, 2022, and the end of the blockade.
